E-vote #2 March 7, 2017

M/S (AC/RR) for Ann and Ron to sign contract agreement with Marriott Mission Valley as host hotel for the 75<sup>th</sup> WCC SD being held July 6-9, 2017. Room Rate is \$159 + room tax (\$179.04) per night. Hotel Guest Parking is \$15 per night with in-and-out privileges. Includes 1/2 Rio Vista Ballroom or entire Rio Vista Pavilion banquet rooms – depending on remodeling lighting status. Banquet room cost is \$500 ++ (\$668.05) each day for 4 days. Daily Parking with one-in-and-out privilege is \$10. Yes=6 No=0 Abstain=0 **PASS**

**A. Committee updates:**

- Final on F2016 trophies – Ann distributed corrected trophies; champagne not distributed; certificates distributed at Captains Meeting.

WCC participants. Parking is \$15 for Hotel guests with I/O privileges and \$10 for same day one time I/O.
