Report on Action Items

1. **Unpaid fees** - All old fees paid, currently owing at \$80.
2. **Fall Tournaments**
 - a. Attendance is roughly 2x last season. 51 players so far.
 - b. \$540 in fees collected
 - c. Open Individuals tourney on 12/21. 15 registered so far.
3. **Awards Banquet and trophies**
 - a. The trophy list below reviewed and approved.
 - b. Brooke to send Patrick the player list teams, individuals, table runs and 4-0. Jay to provide tournament winners.
 - c. Board approved holding the awards party at Stone Brewing Liberty Station.
4. **Spring Calendar**
 - a. Jay anticipates at least 4 new teams for S26. We will have 3 divisions with 8 teams each. If we have more than 3 new teams, then 3 divisions with 9 teams. We will leave space in the C division to add new teams mid-season.
 - b. 3x9 format will leave 2 weeks for playoffs, requiring 1) playoff by division or 2) Semi-final and final matches on a Sunday.
 - c. Board approval via email vote once the schedule is finalized.
